- (i) Must have demonstrated excellence in academics by having a cumulative average score of at least 70.00%.
- (ii) Must have demonstrated excellence in leadership, community service, cocurricular and extra-curricular activities.
- (iii) Must not have been involved in any disciplinary or examination irregularity case while being a student at the University.
- (iv) Should not owe any fees to the University.

You can submit your applications by filling the prescribed application form (attached) and submitting the same to the office of Registrar, Academic and Student Affairs via email reg.asa@maseno.ac.ke or by dropping the application at the office of Registrar ASA at Main Campus. The deadline for submission of applications is 13th September 2023. Successful applicants will be contacted by the office of the Registrar, Academic and Student Affairs within two weeks of Senate approval.
